- 1.1 <u>DELETE</u> the fourth paragraph on page 20 of the IFB in EXHIBIT A "BID SPECIFICATIONS OR EQUIVALENT and replace with the text: Due to Executive Order 2020-30, with regard to the ongoing need for janitorial services, there is no mandatory site visit required to be considered for award of this contract. The University of Guam is currently closed to the public, therefore the Residence Life Office has issued pictures (*refer to Amendment 2 issued on September 23, 2020*) of each section to be included in the requirement for cleaning services so that these factors may be considered in the preparation of any submittals. All Bidders will be responsible for any error, omission, or other mistakes contained in their proposal.

#### INTERESTED BIDDER: ADVANCE MANGEMENT INC.

#### **QUESTION SET A: 1 - 5**

1. May we request the name of the current service provider and the winning bid amount?

#### ANSWER: PLAN B Corporation. Monthly services at \$8,325.00.

2. We are unable to determine the duration of the bid as there is no indication in the bid documents.

3. Exhibit A, paragraph 4, states: "the UOG has designated a time and date above for the Bidders to make site visits......" and that "Bidders ARE REQUIRED to tour the facilities......" Please advise the date and time for the site visit as we are unable to locate that information in the bid document.

4. Under Exhibit B, Bid Price Form, it is indicated that "cleaning supplies to be included **but not limited to** toilet tissue, soaps and trash bags." May we request clarification as to what other cleaning supplies UOG may require so we can include those costs in our bid?

5. DOES THIS REQUIRE A CLEANER TO BE ON SITE FROM 8:30AM thru 4:30PM? OR DOES IT MEAN THAT THE WORK IS ONLY TO BE PERFORMED DURING THAT PERIOD, REGARDLESS OF THE LENGTH OF TIME IT TAKES TO COMPLETE?

#### ANSWER: 8:30am thru 4:30pm are the Hours of work to conduct cleaning.
