Question 1: Per the UOG BID No. B21-18 Instruction to Bidders Page 8 & 9, Item 12,

- "...a Bid Security or standby irrevocable Letter of Credit or Certified Check or Cashier's Check or
 other security supplied in a form satisfactory to the University in the same bid envelope to be held
 by the University of Guam (UOG)."
- "...The Original Bid Security must be submitted to the UOG Procurement office on or before bid submission deadline."

Per Attachment D Bid Security Page 13 states, "...NOW, THEREFORE, if the University of Guam shall accept the bid of the Principal, the Principal shall enter into a Contract with the University of Guam in accordance with the terms of such bid, and give such bond or bonds as may be specified in bidding or Contract Documents with good and sufficient surety for the faithful performance of such Contract and for the prompt payment of labor and material furnished in the prosecution thereof."

 Does the above statement imply the bid bond is not required until the University of Guam accepts the bid?
