Question 1: Please confirm the final rack dimensions required. In reference to PDS's question 1, UOG advised that the dimensions are either 42U or 44U. Please confirm as there is a price difference.

Answer: UOG confirms 42U

Question 2: Equipment list displays 10U of equipment requirements, please advise if UOG is open to consider a one-half rack fractional cabinet of 21U for economic benefits. The cabinet dimensions are (30" x 36").

Answer: UOG accepts a 21U rack. The rack should provide physical security from unauthorized access to UOG equipment.

Question 3: Please clarify that the grand total price will be the total bid price x 2 years, for table 1 and 2 in exhibit B.

Answer: UOG: Please disregard the table 2.0 options. Cost will only be considered on Exhibit B Table 1.

Question 4: Please confirm the deadline for submission of bid package. Amendment 4, 1.1 shows bid submission deadline is 1/24, but 1.2 shows 1/31.

Answer: UOG confirms Bid submission deadline is 1/31/2024. Deadline for questions and clarifications is 1/24/2024, which is five (5) business days before bid submission deadline.

Question 5: To provide the correct PDU, please advise on the following:
a. What kind of input power does UOG have?

Answer: 100 – 240 VAC

b. How many outlets do UOG devices need?

Answer: Initially, UOG requires 10 outlets. However, UOG needs the option to expand in the future in the event more equipment is installed in the rack.

c. What kind of plugs does UOG devices have? Example below.

Answer: **NEMA 5-15P**

d. Are there any other features needed? Example below.

Answer: **Basic PDU, UOG would like the option to expand in the future.**

Question 6: Please confirm if 120 dual feed electrical power is acceptable to UOG.

Answer: **UOG: Yes.**
