Q 1.) ... Please let us know if you still want us to provide Fire Sprinkler even if it is not required per IBC and Life Safety code.

#### Dear Ms. Gumataotao:

Q1

This is in connection with your Amendment #6 which states that a Fire Sprinkler is required and must meet Guam Code. Kindly note that this is a Design-Build Project, and it is our Designers of Record responsibility to comply with the RFP requirements and current codes.

Upon review of IBC and Life Safety Code by our Designer of Record, we are providing the following information for your perusal and consideration:

- 1. Educational facilities above 12th grade are considered 'B' occupancy.
- B occupancies other than ambulatory health facilities do not need to be sprinklered based on occupancy. They will need to be sprinklered if it exceeds the area limits for construction types. Since we will be using all concrete for the structure (Type 1), there are no limits.
- 3. Based on the above fire sprinklers are not required.

Please let us know if you still want us to provide Fire Sprinkler even if it is not required as per IBC and Life Safety code.

A 1.) An automatic sprinkler system is an OPTION for the SENG building construction. But, it will be required to be part of the A&E drawing package. The option should focus on automatic sprinklers for the non-computer laboratories at the University of Guam as the National Fire Protection Association has designated such labs as: "(4) Laboratories, instructional — business occupancy." Plans should follow Chapter 12 of NFPA 45.
